

Cómo cambiar el nombre de una iglesia

Cuando la iglesia local quiere usar un nombre diferente de su nombre legal, la iglesia tiene 2 opciones:

1. Adoptar un nombre asumido o nombre ficticio, o puede
2. Enmendar estatutos de la organización para cambiar su nombre

Adoptando un nombre asumido o ficticio

Los estatutos de corporaciones de sin fines de lucros proveen oportunidades para adoptar un nombre "asumido" o "ficticio". Este proceso se conoce como registrando su nombre "Doing Business As" (Haciendo Negocios Como). Un nombre ficticio es un nombre que es diferente de su nombre legal. Si su corporación ya ha sido establecida y usted desea un nombre distinto al nombre actual de sus artículos de corporación, usted necesitara registrar el nombre como "Doing Business As". (DBA)

Esto debe ser considerado por muchas iglesias cuando buscan versiones abreviadas que son más fáciles de decir en conversaciones informales. Por ejemplo, cuando el nombre legal de la iglesia es Life Evangelical Covenant Church y escogen usar el nombre Life Covenant.

El proceso para adoptar un nombre asumido es diferente en cada estado, el proceso general es lo siguiente:

- Contacte o visite la página de web de la oficina del Secretario de Estado
- Busque el formulario para adoptar un nombre asumido, ficticio, DBA
- Llene y envíe el formulario con su cuota

Cuando el formulario sea aceptado por el gobierno de su estado, la iglesia mantendrá su nombre legal y también podrá operar bajo su nuevo nombre. Si la iglesia provee a su banco la registración con el estado, podrán cambiar el nombre en la cuenta bancaria. **Pero tendrán que usar su nombre legal cuando paguen sus impuestos de empleador y envíen formas W-2 y las formas IRS 941.** Al usar el nombre asumido en estos formularios, serán rechazados.

Las ventajas en adoptar un nombre asumido son:

- No se requiere cambiar el nombre en todas las cuentas o títulos de propiedades
- Mantendrá su nombre legal en los archivos público por lo cual será fácil para alguien buscar su nombre si buscan dejar dinero de un testamento o fondo en fideicomiso

Las desventajas en adoptar un nombre asumido son:

- El nombre asumido tendrá que ser renovado a cierto tiempo, puede ser anualmente, semestralmente, cada tres años, etc
- Con cada renovación del nombre asumido tendrá que pagar una cuota
- El nombre asumido no previene que otra organización use el mismo nombre asumido

Enmendando estatutos para cambiar su nombre

Las iglesias pueden cambiar su nombre al enmendar los estatutos de la organización. Al usar este proceso, la iglesia cambiara su nombre legal de su historia archivado con el Secretario de Estado indicando todo los nombres anterior y corriente. Como resultado del cambio de nombre, la iglesia necesitara cambiar su nombre en todas las cuentas incluyendo las cuentas con el IRS. Algunos estados piden que las iglesias cambien su nombre en los títulos de sus propiedades, aunque no sea necesario legalmente.

El proceso de enmendar sus estatutos es lo siguiente:

- Busque el formulario para enmendar sus estatutos en la página de web del Secretario de Estado
- Llene y envíe el formulario con la cuota. Típicamente el formulario requiere que usted provee la información: (ver ejemplo adjunto)
 - Número del archivo proveído por el Secretario de Estado- este número se puede encontrar en la página de web del Secretario de Estado
 - Nombre corriente de la corporación
 - Como fue la enmienda adoptada, por ejemplo, voto de miembros, voto por directores, y la fecha de adopción
 - De que enmienda se trata. En algunos estados usted tendrá que conocer que son sus artículos para poder enmendar la sección correcta. Típicamente el nombre de la corporación se encuentra en el Artículo 1
 - La firma de un oficial autorizado. En algunos estados, tendrá que ser uno de los oficiales que esta nombrado con el Secretario de Estado

Una vez la enmienda está registrado con la oficina del secretario del estado, usted recibirá una copia marcado, "Filed" (Archivado) y su nombre será cambiado. El Secretario de Estado mantendrá un archivo de sus nombres anteriores, y su nuevo nombre será usado de aquí en adelante.

Al cambiar el nombre, la iglesia debe informar al fisco (IRS) es su informe anual, el Formulario 990 sobre su cambio en su nombre y asegurar que su nombre nuevo identifique con su número federal de identificación de empleador, FEIN. Más información en cómo cambiar su nombre esta adjunto. Si su iglesia no llena el formulario de impuesto 990 (cuales muchas iglesias no llenan) usted tendrá que mandar una carta firmada con sus artículos enmendado y marcado "Filed" (Archivado) al:

NOTES

1. State the true and exact corporate name as it appears on the records of the Secretary of State BEFORE any amendment herein is reported.
2. Directors may adopt amendments without member approval only when the corporation has no members, or no members entitled to vote pursuant to §110.15.
3. Director approval may be:
 - a. by vote at a director's meeting (either annual or special), or
 - b. by consent, in writing, without a meeting.
4. All amendments not adopted under Sec. 110.15 require that:
 - a. the board of directors adopt a resolution setting forth the proposed amendment, and
 - b. the members approve the amendment.

Member approval may be:

- a. by vote at a members meeting (either annual or special), or
- b. by consent, in writing, without a meeting.

To be adopted, the amendment must receive the affirmative vote or consent of the holders of at least two-thirds of the outstanding members entitled to vote on the amendment (but if class voting applies, also at least a two-thirds vote within each class is required).

The Articles of Incorporation may supersede the two-thirds vote requirement by specifying any smaller or larger vote requirement not less than a majority of the outstanding votes of such members entitled to vote, and not less than a majority within each class when class voting applies. (Sec. 110.20)

5. When member approval is by written consent, all members must be given notice of the proposed amendment at least five days before the consent is signed. If the amendment is adopted, members who have not signed the consent must be promptly notified of the passage of the amendment. (Sec. 107.10 & 110.20)



Change of Name - Exempt Organizations

An exempt organization that has changed its name must report the change on its next [annual return](#) (such as Form 990 or 990-EZ). An organization that does not file an annual return (for example, an organization that instead files [Form 990-N, the e-Postcard](#)), or an organization that is required to e-File its return, may report the change of name by letter or fax (not by phone) to [Customer Account Services](#).

The particular supporting documentation required to report a change of name depends on the type of organization. The chart below sets forth the supporting documentation required:

If Your Organization Is	The Request Must Include
Incorporated	A copy of the amendment to the Articles of Incorporation, and proof of filing with the appropriate state authority.
A Trust	A copy of the amendment to the trust instrument, or a resolution to amend the trust instrument, showing the effective date of the change of name and signed by at least one trustee.
An Unincorporated Association	A copy of the amendment to the Articles of Association, Constitution, or other organizing document, showing the effective date of the change of name and signed by at least two officers, trustees or members.

The letter or fax reporting the change of name must include your organization's

- full name (both the prior name and the new name)
- Employer Identification Number and
- authorized signature (an officer or trustee)

The individual signing the letter must state the capacity in which he or she is signing (for example, "John Smith, President").

If you need to report a change of your organization's address, see [Change of Address – Exempt Organizations](#).

The [EO Determinations Office](#) can issue an [affirmation letter](#) showing an organization's new name and affirming the section of the Internal Revenue Code under which IRS records show the organization as tax-exempt and whether contributions to the organization are deductible.
